Came to Utah Sept 30<sup>th</sup> 1847 -  
Prior to this time he was closely associated with the Prophet his home was open to the Mormons to come and go as they pleased - He was baptized in 1841 visited Nauvoo the same year gave many thousands of dollars in goods and money to the church Joseph Smith was hidden in his home from his enemies many times on one occasion he received the last part of the Baltimore for the Dead Wm Clayton was also present -  
After the Prophet was killed - He and O. Huntington carried the bodies of Joseph and Hyrum from the mansion house to the Nauvoo House and buried them both in one grave. Later he was made Presiding Bishop of the church which office he held until death.
