"Revelation to John Taylor" Salt Lake City, Utah, Nov. 19, 1877.

I have been asking the Lord to show me how to adjust the property belinerchined in the name of the late President Brigham Young so as to do justice to his estate and yet not wrong the Church. I have received the following answer: 'You have asked of me and others of the Twelve have asked of me that wisdom might be given to you to adjust these property matters of the Church. Thus saith the Lord, Be one, be united, be honest, act upon the principles of justice and righteousness to the living and to the dead and to my Church, and I the Lord will sustain you and will acknowledge your labors, Amen. ""

From Geo. Q. Cannon papers (handwritten in ink).

TO WHOM IT MAY CONCERN: This is to certify that George Q. Cannon is an elder of the Church of Jesus Christ of Latter Day Saints in good standing and as such I recommend him to all Saints and to all men wherever his lot may be cast, praying God, the Eternal Father, that He will bless all who will receive him and administer to his necessities inasmuch as he may have need.

President George Q. Cannon started making improvements in that part of Salt Lake Valley now included in the boundaries of Cannon Ward in 1870, and he soon located one of his families in what is still called "the Farm House". The ground on which Pres. Cannon made his first improvements was very wet and swampy, and it needed a great deal of ditching and draining to make it fit for habitation. Pres. Cannon butilt a school house in about 1879, and immediately after the completion of the same a day school was commenced which was taught by Mrs. Martha Telle Cannon as early as 1879.

Pres. Cannon continued to make improvements and built a number of houses on the east bank of the Jordan River. In due course of time other settlers located in the same neighborhood, and as most of these resided far away from the adjoining ward centers it was deemed wise to organize the Saints residing in that part of Salt Lake Valley into a separate ward. Consequently, a special meeting was held in Pres. Cannon's school house, May 31, 1896, attended by Pres. Geo. Q. Cannon, Apostles Brigham Young and Abraham H. Cannon, Pres. Angus M. Cannon and Joseph E. Taylor of the Salt Lake Stake Presidency and many members of the Brighton and Fifth Wards. On this occasion the Saints residing within the following described boundaries were organized as the Cannon Ward:

Bounded on the north by 9th South Street, on the east by 6th West, on the south by 13th South and on the west by Redwood Road. Some of the Saints who became members of the new ward were formerly members of the 5th Ward, others to the Farmers Ward and still others to the Brightom Ward. The new Cannon Ward comprised Saints residing on both sides of the Jordan River. Lewis Mousely Cannon, a son of Pres. Angus M. Cannon, was chosen as bishop of the new ward. He was ordained a High Priest and Bishop and set apart to preside over the Cannon Ward by Pres. Geo. Q. Cannon, Cyrus Henry Gold was ordained a High Priest by Apostle Brigham Young and set apart to act as First Counselor to Bishop Cannon. Alma H, West was chosen and sustained as second counselor to Bishop Cannon, but being absent from the ward temporarily, he was not ordained until later.

Angus Jenne Cannon was appointed Ward Clerk. For a short time after the organization of the ward meetings were held in Pres. Geo. Q. Cannon's private school house, but steps were taken almost immediately towards the erection of a new meeting house, the

bricks for which were made in 1896. The foundation for the meetinghouse was also laid that year and 800 loads of sand hauled on the ground to raise it above the wet low land surrounding it. The one acre of land on which the meetinghouse was built was donated by Pres. Geo. Q. Cannon.

In 1897 work on the new ward meeting house was pushed forward vigorously, and the building brought under a roof before the close of that year. It is a brick structure, 60' by 30', situated on 8th West Street between 10th and 11th South. In Sept. 1899, Elders Sylvester Q. Cannon and William T. Cannon went on a mission to the Netherlands. Brother Sylvester Q. Cannon returned Nov. 15, 1902, and William T. Cannon returned in 1901. Elder Sylvester Q. Cannon presided over the Netherlands and Belgium Mission.

A new ward chapelwhich had been erected at a cost of \$50,000, was formally opened on May 29, 1927. This building was located on 8th West between 13th and 14th South.

Some of the Saints who became members of the new ward had formerly belonged to the 5th ward, others to the Farmers Ward, and still others to the Brighton Ward. The new Cannon Ward comprised Saints residing on both sides of the Jordan River. Lewis Mousley Cannon, a son of Angus M. Cannon, was chosen as the bishop of the new ward. He was ordained an high priest, and bishop, and set apart to preside over the Cannon Ward by Pres. Geo. Q. Cannon. Cyrus Henry Gold was set apart by Apostle Brigham Young to act as 1st counselor. Alma H. West was chosen and sustained as 2nd counselor. Angus Jenne Cannon was appointed ward clerk.

For a short time after the organization of the ward, meetings and Sunday Schools were held in Pres. Cannon's privaterschoolhouse, but steps were taken almost immediately toward erection of a new meetinghouse for which the bricks were made in 1896. The foundation for the meetinghouse was also laid that year, and 800 loads of sand were hauled to raise it above the wet low land surrounding it. The one acre of land upon which the meetinghouse was built was donated by Pres. Cannon.

In 1897 work on the new meetinghouse was pushed forward vigorously and the building brought under a roof before the close of that year. It was a brick structure, 60 ft. by 30 mft., situated on 8th West between 10th and 11th South. In Sept., 1899, Sylvester Q. Cannon and William T. Cannon went on a mission to the Netherlands. Elder Sylvester Q. Cannon returned on Nov. 15, 1902, and William T. Cannon returned in 1901. Elder Sylvester Q. Cannon presided over the Netherlands-Belgium Mission.
